We would like to inform you that Hon'ble NCLT Chennai has allowed the Company application as filed by the Liquidator of Shree Ambika Sugars under Section 230-232 and 66 of the Companies Act, 2013, read with the applicable provisions of Insolvency and Bankruptcy Code, 2016, the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations, 2016 Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 and Rule 11 of NCLT Rules, 2016 in relation to the Scheme of Arrangement (hereinafter referred to as the "SCHEME") proposed by the SNJ Distillers (P) Ltd.

As per the directions issued by the Hon'ble NCLT Chennai all the Stakeholders except Secured Financial Creditors shall be represented only by their Authorized Representative and the Authorised Representative shall be appointed in the manner as contemplated under sub-section (6) and subsection (6A) of Section 21 of IBC, 2016 read with Regulation 4A and Regulation 16A of IRPCP Regulations, 2016 as applicable during the CIRP of a Corporate Debtor.
